Important Information

- Using explosives underground for the purpose of coal mining is exempt from fire marshal permit requirements for individual blasters.
- Submission of the application does not authorize the applicant to engage in the requested activity.
- You must be at least 21 years of age. (Exception: The Class G - Helper classification only requires the applicant to be at least 18 years of age).
- You must meet the minimum work qualifications for the permit type you are requesting. Qualification Requirements are listed on page 5 of the application.
- The Personal History Questionnaire must be completed.
- The Affidavit must be signed and dated.
- You must provide a copy of your Federal Bureau of Tobacco and Firearms (ATF) Individual Clearance (Class G Helper – Limited is exempt from this requirement). If the ATF clearance is not provided at the time of application and you meet all other requirements for licensure, you will be issued a 90 Day Temporary Permit. If the ATF Clearance is submitted to our office prior to the expiration date of the temp permit, the applicant will receive a permanent license which will expire one year from the date the temp permit was issued at no additional cost. If the ATF clearance is not received by the office prior to the expiration date, the temporary permit will expire, and the applicant will be required to submit a new application for licensure.
- Processing of the application will be delayed if this application and other forms are incomplete.
- If the application is denied, the agency will advise in writing the reason(s) for denial.
- If your application is approved, you will receive your license card by mail.
- Individual Permits to Use Explosives will be valid for one year and must be renewed annually. Should your Permit to Use Explosives lapse for more than 12 months you must submit a new application.

Required Fees

(\$40.00 Permit Fee and \$40.00 Application Review Fee)

Instructions

- Please complete the application legibly in print and in blue or black ink or using a computer.
- In addition to the completed application, the applicant must submit:
 1. One passport sized photograph (1.5" x 1.5") taken within the last 24 months.
 2. An employment verification letter from your current employer. If currently unemployed, submit an employment verification letter from your previous employer.
 3. Copies of two forms of identification. One must be a photo ID. Types of accepted identification: driver's license, passport, social security card, birth certificate, etc.
 4. A copy of your Federal Bureau of Tobacco and Firearms (ATF) Individual Clearance (If Applicable).
 5. For Class G permit types, you must submit a letter of recommendation from your current employer. If unemployed submit a letter of recommendation from a previous employer.
