Fire Protection Layout Technician	NICET Level III required
Journeyman Sprinkler Fitter (Installs, adjusts, repairs, tests and dismantles fire protection systems. Supervises no more than 2 In-Trainings per Journeyman Sprinkler Fitter)	10,000 hrs of work experience & proof of passing the NITC West Virginia Journeyman Sprinkler Fitter exam ( <a href="http://www.nationalitc.com">www.nationalitc.com</a> )
Sprinkler Fitter in Training (May not work unsupervised)	Letter of good standing from employer & currently enrolled in an approved training program
Engineered Fire Suppression Systems Installer	2,000 hrs of work experience & certifications from all specific manufacturers authorizing the applicant to install, alter, extend, maintain or repair their systems
Engineered Fire Suppression Systems Technician	500 hrs of work experience & certifications from all specific manufacturers authorizing the applicant to maintain or repair engineered suppression systems
Pre-Engineered Fire Suppression Systems Installer	Certified by the respective manufacturer to install, maintain, alter, extend, maintain, layout or repair a pre-engineered suppression system
Pre-Engineered Suppression Systems Technician	Certified to maintain or repair a pre-engineered suppression system
Portable Fire Extinguisher Technician	Certified in accordance with NFPA 10
Fire Protection Damper Technician	<b>Do not use this application.</b> Applicant must take and pass Fire Damper Technician's test administered by the WVSFMO. Please request, complete and then submit a Fire Damper Technician's application.
Fire Protection Damper Technician In-Training	Applicant is a least eighteen years of age and shall provide documentation that he or she is enrolled in a training program.

If you have an installer license, you do not need the technician license
